Housing Preservation Initiative (HPI)

HPI is a flexible program to support neighborhood groups in the development of strategic, grassroots-based solutions that directly address the particular threat to affordable housing in each community.

ANHD respectfully requests that funding for the Housing Preservation Initiative (HPI) be increased to \$2.5 Million from \$2 Million to increase funding to grantees and allow HPI to expand to additional neighborhoods .

Community Consultant Contracts (CCC)

CCC provides core funding for the front-line anti-displacement services that community groups provide. When a community resident is at-risk of eviction, or when a constituent-service staff person needs assistance with a housing case, they call the CCC-funded anti-eviction /displacement specialist , whoa re able to use all available tools to keep City residents in housing they can afford.

ANHD respectfully requests that funding for the Community Consultant Contract (CCC) be increased to \$1,200,000 from \$1,000,000.

NPCP provides consistent funding for community-based, nonprofit partners to work with tenants, landlords, and the city to preserve affordable housing, ensure neglected properties do not have a negative impact on the broader community, and protect tenants from eviction and dangerous living conditions throughout the city.

ANHD respectfully requests that funding for the Neighborhood Preservation Consultant Program (NPCP) be restored to \$1,160, 000, reversing the over 72% cut which reduced the program to \$580,000.
